1 **REQUEST FOR PRODUCTION NO. 1:**

2 Copies of all Federal Income Tax Returns for the past three
3 (3) years.

4 **REQUEST FOR PRODUCTION NO. 2:**

5 Copies of all pay stubs evidencing your income for the past
6 three (3) years to present from any and all employment; in the
7 event you do not receive pay stubs, any and all documentation
8 verifying your gross monthly income.

9 **REQUEST FOR PRODUCTION NO. 3:**

10 A copy of your marriage certificate.

11 **REQUEST FOR PRODUCTION NO. 4:**

12 Copies of all monthly statements from all banking or
13 financial institutions, in which you have had any type of
14 checking, savings, money market, certificate of deposit, or
15 other type of account, whether a personal account or business
16 account, from the past three (3) years to the present date. This
17 should also include any accounts into which you have made any
18 deposits or from which you have the right to withdraw.

19 **REQUEST FOR PRODUCTION NO. 5:**

20 Copies of all checks, deposit slips, passbooks, check
21 registers, or ledgers relating to the accounts divulged in
22 compliance with request number 4 for the past twelve (12) months
23 through to the present date.

1 **REQUEST FOR PRODUCTION NO. 6:**

2 A Domestic Relations Affidavit of Financial Condition
3 executed by you and accompanied by all supporting documentation
4 including, but not limited to, financial statements, bank
5 statements, billing statements, check registers, and income tax
6 returns.

7 **REQUEST FOR PRODUCTION NO. 7:**

8 Copies of all documents reflecting or pertaining to your
9 living expenses for the past twelve (12) months to the present,
10 including without limitation, ledgers, journals, check
11 registers, and canceled checks reflecting payments during that
12 period for mortgage, rent, property tax, real property
13 insurance, house repairs, gardener, household help, food at home
14 and household supplies, food dining out, utilities (gas, water,
15 power), telephone, laundry and dry cleaning, clothing, medical
16 and dental expenses, medical insurance, pets, charity, cable
17 television, vaccinations, incidentals (including cigarettes,
18 drug store, magazine subscriptions, alcohol), entertainment and
19 recreation, automobile insurance, automobile maintenance (gas
20 and oil).

21 **REQUEST FOR PRODUCTION NO. 8:**

22 Copies of all documents reflecting your use of credit
23 cards, reflecting all purchases made in the last two (2) years.

1 **REQUEST FOR PRODUCTION NO. 9:**

2 Copies of all documents reflecting any debt incurred by you
3 personally and/or through any business entities for the last two
4 (2) years to the present date.

5 **REQUEST FOR PRODUCTION NO. 10:**

6 A copy of the transcripts of each degree you hold and any
7 professional licenses or qualifications you currently hold or
8 previously held.

9 **REQUEST FOR PRODUCTION NO. 11:**

10 A copy of your current and past employment contracts with
11 xxxxx and xxxxxx.

12 **REQUEST FOR PRODUCTION NO. 12:**

13 Copies of all documents reflecting each automobile or other
14 motor vehicle presently owned or leased by you for your use or
15 benefit, including without limitation, the title, all appraisals
16 thereof, and writings reflecting encumbrances thereon. In
17 responding to the request, please include any documents related
18 to the purchase of such vehicles and the trade-in of any
19 community assets toward such purchase.

20 **REQUEST FOR PRODUCTION NO. 13:**

21 Copies of all documents reflecting or referring to each
22 vault or safe or safety deposit box maintained or used by you in
23 the twelve (12) months to the present and the contents thereof.

1 **REQUEST FOR PRODUCTION NO. 14:**

2 Copies of all documents relating to any illness, condition,
3 behavior, personal, marital, or situational matter for which you
4 have been treated for, or have received consultation for, within
5 the past twelve (12) months through the present date, including

7 hospital charts and records, medical prescriptions, receipts for
8 purchase of drugs, admission and release forms and any other
9 types of medical analysis from doctors or other health
10 professionals.
